

# Net Zero Commitment – Southern Implants UK Ltd Southern Implants UK Ltd Net Zero Commitment Statement

Southern Implants UK Ltd commits to achieving Net Zero greenhouse gas emissions by 2050 for our UK operations.

We recognise our shared responsibility with the NHS and wider healthcare sector to reduce carbon emissions and accelerate the transition to a sustainable, low-carbon supply chain. Our commitment aligns with the NHS Net Zero Supplier Roadmap and the UK Government's Procurement Policy Note (PPN 06/21).

## **Scope of Commitment**

This commitment covers greenhouse gas emissions from:

- Scope 1 Direct emissions from operations (e.g., fuel used in company-owned or controlled vehicles or equipment).
- Scope 2 Indirect emissions from purchased electricity consumed at Southern Implants UK
  offices.
- Scope 3 (subset) Indirect emissions related to business travel, waste generated in operations, purchased goods and services, and upstream transportation and distribution, as required by the NHS from April 2024.

#### **Actions Taken to Date**

Southern Implants UK has already begun implementing meaningful carbon reduction measures, including:

- Installation of 27 solar panels and an onsite battery storage system on our UK headquarters, providing over 75% of the site's electricity needs from renewable sources in 2025.
- Prioritising energy efficiency across our facility, including optimisation of heating/lighting usage and reduction of energy-intensive equipment where feasible.
- Partnering with the accredited agency, Positive Planet, to calculate our Scope 1, 2, & 3 emissions in line with the GHG protocol and create a compliant Carbon Reduction Plan.

These investments ensure that the majority of our electricity consumption is generated on-site from renewable energy, significantly reducing our Scope 2 emissions.

### **Our Approach Going Forward**

To reach Net Zero by 2050, we will:

- Measure and report our Scope 1, Scope 2, and mandatory Scope 3 emissions every year in CO<sub>2</sub>e.
- Prioritise absolute emission reductions before considering the use of offsets.
- Expand carbon efficiency initiatives across our operations and supply chain.

- Engage suppliers and logistics partners to reduce upstream emissions.
- Publish annual updates on emissions reduction progress.
